B-Kleer[™] Mint Mask

Indications

- To clean pores, absorb excess oils and improve the tone and texture of the skin.
- Remove blackheads.

Key Features

- Excellent for combination, oily and acne-prone skin types.
- Kaolin absorbs oils in the skin's pores.
- Contains Bentonite to dry the pores and reduce shine.
- Trace of mint adds freshness and soothing properties.
- High quality metal oxides to fight bacteria and soothe irritations.
- May be used prior to applying glycolic acid.
- Wait 20-30 minutes to apply AHAs after rinsing off the mask.

Directions

- Apply liberally over entire face, avoiding the eyes.
- Allow to set for 10-15 minutes.
- Gently rinse off with lukewarm water, do not rub.
- Pat the skin dry.
- Apply Ultra Lite Facial Moisturizer if desired.
- Use 2 times a week.
- Recommend a Shammy Wash Cloth so as not to irritate the skin.

Warning

- For external use only.
- Keep out of reach of small children.
- Avoid contact with eyes and mucous membranes.
- If irritation develops, discontinue use.
- Do not use on dry or mature skin.
- If using glycolic acid, remove mask and allow skin to dry for 30 minutes before applying AHA/Glycolic Acid.

B-Kleer[™] **Sulfur Mask** (OTC Drug)

Indications

• For the treatment of acne. Helps clear up acne blemishes and allows the skin to heal. Penetrates pores to reduce the number of acne blemishes and helps prevent new blemishes from forming.

Key Features

- Use to fight and control acne.
- Therapeutic Sulfur base helps dry out pores.
- Titanium dioxide.
- Bentonite clay helps to absorb impurities and soak up excess oils.
- Kaolin clay acts as an astringent and helps to cleanse by removing excess oils and slough dead cells.
- Excellent treatment for oily skin problems.
- Use 1-3 times weekly, but no more than three times weekly.

Directions

- Cleanse the skin thoroughly before applying medication mask.
- Cover the entire affected area with a thin layer no more than three times a week.
- Leave on for 10 12 minutes.
- Rinse thoroughly with lukewarm water.
- Because excessive drying of the skin may occur, start with one application a week, and then gradually
 increase to two or three times weekly as needed or as directed by a doctor.
- If dryness or peeling occurs, reduce application to once a week or once every other week.
- Avoid the eye zone.
- This product should not be left on the skin more than 12 minutes.
- Sensitivity Test for a New User: Apply product sparingly to one or two small affected areas during the first few days. If no discomfort occurs, follow the directions stated above on this label.

Warning

- For external use only. Not to be ingested.
- Do not use if using Accutane[®].
- Using other topical acne medications at the same time or immediately following use may increase dryness or irritation of the skin. If this occurs, only one medication should be used unless directed by a doctor.
- If excessive skin irritation develops or increases, discontinue use and consult a doctor.
- Avoid getting into eye area.
- Keep away from children.
